- Copy of the last payment settled to the relevant Authors' Society or any other collecting society lawfully authorised to manage authors' rights
- Information on whether you have distribution agreements with any digital distribution companies
- Proof of membership of a music licensing company (MLC) in another country
- Recording contract with an artist (removing financial and personal data)
